SPECIFIC GENERAL BEQUEST

"I give to Old World Wiscons	sin Foundation, a Wisconsin nonprofit organization, or its successor

RESIDUARY GENERAL BEQUEST

"I give to Old World Wisconsin Foundation, a Wisconsin nonprofit organization, or its successor organization, (all or a % of) the residue of the property owned by me at death, real and personal and wherever situated to be used for its general support and charitable purposes without restriction."

"GREATER OF" RESIDUARY GENERAL BEQUEST

"I give to Old World Wisconsin Foundation, a Wisconsin nonprofit organization, or its successor organization, the greater of _____ % of my estate or \$_____ to be used for its general support and charitable purposes without restriction."

Contingent Gifts in a Will

It is possible that the primary b	peneficiary or beneficiaries of one's estate may not be there in
the future. In such case, a cont	ingent bequest naming Old World Wisconsin Foundation as a
contingent beneficiary can pro-	vide a meaningful alternative.

Bequest Restricted for a Specific Use

Some donors desire their gift to support a specific project, program, or area of research. Restricted bequests are fine, although it is important they provide for some flexibility to adapt to changing needs and programs.

"I give to Old World Wisconsin Foundation, a Wisconsin nonprofit organization, its successor organization, the sum of \$______ (or % of my estate), (or other personal property herein described) to be used for (designated purpose*). If at any time it becomes impossible or impractical for my gift to be used for the above designated purpose, Old World Wisconsin Foundation shall use my gift for a purpose and in a manner that it determines most closely meets the above designated purpose."
